#### 1) Rates and Charges

Council rates and charges have been reviewed for the 2022/2023 year with the following changes proposed.

Total Rate yield will increase by .7% permissible rate pegging amount plus \$44,385 carry over amount.

Yield from Farmland Rate Categories increased from 52.5% of Total Yield to 55%.

Sewerage and waste charges have increased by 2%

Water Charges have increased by 3.9% in accordance with Developer Servicing Plan
