1) Rates and Charges

Council rates and charges have been reviewed for the 2024/2025 year with the following changes proposed.

Total Rate yield will increase by 4.5% permissible rate pegging amount.

Yield from Farmland Rate Categories increased from 57.5% to 60%.

Water charges have increased by 4.5 %. Waste Charges increased to cover cost of three bins per service. Sewer Charges increased by 4.5%.
