Please use this form to pay for an annual permit, as required under the *Companion Animals Act 1998*, for a cat over four months of age that is not desexed, a declared dangerous dog, and/or a restricted dog by breed. Please note, if you are the owner of a restricted dog and it is declared dangerous, you will need to pay for two permits. Annual permits apply in addition to the one-off lifetime registration fee.

What happens now

The registration agent should give you a copy of this form. They must then enter the information on the NSW Companion Animals Register within 7 days. Once the information has been entered on the Register, you will be able to view your pet's annual permit status on the NSW Pet Registry and print an updated Registration Certificate.

If you have not set up a profile and claimed your pet on the NSW Pet Registry, please visit www.petregistry.nsw.gov.au and follow the steps required to claim your pet.

How long this permit lasts

Annual permits are valid for 12-months from the date of issue, or another date specified in the permit, unless it is surrendered, removed or revoked earlier.

What to do if you sell or giveaway your cat

If a cat with an annual permit is sold or transferred to a new owner, that permit continues to apply to the animal for the remainder of the 12-month period, unless it is surrendered, removed or revoked earlier. The new owner is responsible for complying with any conditions of the permit.

Dangerous and restricted dogs

It is an offence to sell, give away, advertise for sale or transfer ownership of a dangerous or restricted dog (or a proposed dangerous or restricted dog). A maximum penalty of 150 penalty units may apply.
